# ARTICLES OF INCORPORATION ANIMAL PROTECTION SOCIETY of the SAN JUANS Orcas Chapter

The undersigned, for the purpose of forming a corporation under the nonprofit laws of the State of Washington, RCW 24.03, hereby adopts the following Articles of Incorporation:

#### ARTICLE I

The name of the corporation shall be the Orcas Chapter of the Animal Protection Society of the San Juans.

#### ARTICLE II

The term of existence shall be perpetual.

#### **ARTICLE III**

The purpose of the corporation is to maintain and operate an animal shelter for benefit of the public, to provide services for the humane disposition of unwanted animals, and to educate the public about the humane care of animals.

This corporation is organized exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue law) or (b) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue law).

#### ARTICLE IV

The name of the Registered Agent of the corporation is Marsha K. Waunch.

The street address of the Registered Office, which is also the address of the Registered Agent is as follows:

#### ARTICLE V

There shall be 15 directors serving as the initial Board of Directors. Their names and addresses are as follows:

#### ARTICLE VI

In the event of dissolution of the corporation, the net assets are to be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code (or a corresponding section of any future tax code) to a charitable, non profit animal welfare organization, or to the Federal Government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations as said court shall determine, which are organized and operated exclusively for such purposes.
